MINUTES FOR TOWN OF AHNAPEE/TOWN OF FORESTVILLE JOINT TOWN BOARD MEETING

Held at the Forestville Town Hall, 7701 Co. H, Sturgeon Bay, WI. 54235 at 6:30 P.M.

Present for the Town of Ahnapee were Chairman Gary Paape, Supervisors Ken Draves and Tom Stoller, and Sharon Grosbeier, Clerk. Present for the Town of Forestville were Chairman Roy Englebert, Supervisor Larry Huber and Ruth Kerscher, Clerk. Also present was Attorney Tyler Pluff from Pinkert Law Firm, Sturgeon Bay, WI.

The meeting was called to order by Chairman Gary Paape at 6:30 P.M.

Gary Paape read the Ahnapee Town posted notice and stated a copy of the notice was sent to Andrew and Tamara Romdenne.

Clerk Ruth Kerscher read the meeting notice posted by the Town of Forestville.

The purpose and discussion of the meeting was regarding ownership of County Line Road between Old Substation Road and Carnot Road. The orders of ownership originally were recorded on May 23, 1902 and again on May 29, 2018 by the Town of Ahnapee and the Town of Forestville.

On September 18, 2018, a "Notice of Claim "was received from Andrew Romdenne.

It was stated that an "Order of Dismissal" was received on August 18, 2020 from the Door County Circuit Court regarding the case involving Andrew and Tamara Romdenne in regard to County Line road. It stated that the Romdenne's will dismiss the case and dismissal will be "**without prejudice**" Romdennes had the right to file a challenge within 30 days. Attorney Pluff stated that the Romdennes **failed** to file a challenge within that 30- day period.

After much discussion, it is agreed that regarding the half mile of County Line Road in question, the Town of Forestville will maintain the first quarter mile (1320 feet) east of Wolf River Drive/Old Substation Road. The Town of Ahnapee will maintain the next quarter mile (1320 ft.) to the east of the first section.

Both Ahnapee and Forestville Towns agreed to hire an outside firm to do brush cutting. Town of Forestville Chairman Roy Englebert will contact the outside firm. The Town of Forestville board discussed installing a culvert and the need of gravel on the western quarter mile.

A motion to adjourn was made by Ken Draves, seconded by Gary Paape. Motion Carried.
Joint meeting was adjourned at 7:20 P.M.
